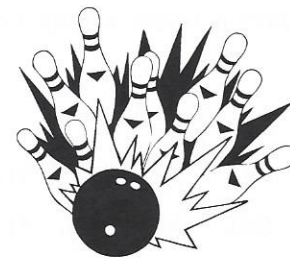

ALL TOURNAMENT RULES APPLY:

1. Men's, Ladies' or Mixed teams may compete in this tournament. Only one card carrying PBA or LPBT member per team. Only USBC sanctioned bowlers are eligible. Non USBC bowlers may qualify for entry and all services by applying for USBC ASSOCIATE DUES of \$21.00. When associate membership is obtained after MAR. 15th of any season, the individual shall become a member for the balance of the current season. Special Participation Memberships for \$5.00 are also available. Membership numbers must be recorded on entry form prior to bowling. ALL ENTRANTS MUST HOLD A VALID USBC MEMBERSHIP CARD BEFORE PARTICIPATION in the tournament to be eligible for awards. Non-USBC members can qualify for entry in the tournament by virtue of obtaining a USBC membership.
2. Scratch Base is 90% of 225.
3. All tournament bowlers who bowl in any kind of sport, challenge or "build your own pattern" league must report their average as such, even if it not certified as a sport/challenge league. You must also turn in the name of the league and bowling center where it is located prior to the start of tournament play. Failure to do so will be grounds for disqualification.
4. Rule 318. All entrants shall use last season's (2017-18) highest USBC sanctioned average of 21 or more games. If no average last season, then entrants may use highest 2016-2017 average. Entrants with no average the past two seasons may use current USBC sanctioned average of 21 games or more, at the time of bowling. ALL OTHERS BOWL SCRATCH, which is 225. Bowlers coming in with an average under 125 will use a 125 average for handicap purposes. The highest average for entrants will be taken from the following:
 - Standard League
 - Sport or Challenge league converted average based on USBC conversion chart, with a minimum of 21 games.
 - USBC Open and/or USBC Women's Open Championship converted average with a minimum of 27 games.
5. All bowlers whose highest current league average (minimum of 21 games) is 15 pins or more higher at the time of bowling, including averages from Standard, Sport, Challenge leagues (whether sanctioned as such or not) or USBC Open/Women's Open Championships conversion, must use that current average. Failure to comply with rule may result in disqualification from tournament.
6. Re-Rate rules apply. Bowlers must notify Tournament Management prior to bowling. Failure to comply with rule may result in disqualification.
7. Teams may participate as often as they wish. Not more than three players on the same team can place more than once in the prize list for position standings. Optional Singles - bowlers may participate as often as they wish, but can cash only once in the top 10 standings.
8. In emergency cases - substitutions during a game will be allowed. Handicaps will be figured on each bowler's average per frame bowled.
9. PARENTAL CONSENT RULE 13 APPLIES. ANYONE FAILING TO COMPLY WITH THIS RULE WILL AUTOMATICALLY FORFEIT ANY WINNINGS FROM THIS TOURNAMENT, TEAM AND/OR INDIVIDUAL.
10. Rule 320b - 329 & 330 apply. This Tournament will be governed by the general playing rules and sanctioned tournament rules in current USBC Rule Book. All decisions of the tournament management are final, unless an appeal is made in accordance with USBC Rule.
11. All Prize/Award Fees Returned 100%. Team prize fees are based on estimated entries of 200.
12. ALL OTHER RULES ARE GOVERNED BY USBC CURRENT YEAR'S RULE BOOK.
